## Sobrac Elections 2022

2023–2024 Biennium

**Abstract:** The election to define the National Board, the Deliberative Council, the Fiscal Council, and the Regional Division Board of the Brazilian Society of Acoustics — Sobrac — took place entirely remotely, following the previous electoral process (2020–2022). The voting system used was Limesurvey, a low-cost, efficient, and secure platform that ensures unique voting through *tokens*. To comply with the institution’s Social Statute (from Article 19 to Article 23) and its General Regulations (from Article 53 to Article 57), the election period was set between September 27 and December 19, 2022. On this latter date, the General Assembly, which was conducted via the Zoom platform, ratified the election results. The participation of voting members was excellent, reaching ninety-three point seven percent (93.7%).

### Eleições Sobrac 2022 (Biênio 2023–2024)

*Resumo:* A eleição para definir a Diretoria Nacional, o Conselho Deliberativo, o Conselho Fiscal e as Coordenações Regionais da Sociedade Brasileira de Acústica — Sobrac — ocorreu de forma inteiramente remota, a exemplo do processo eleitoral anterior (2020–2022). O sistema de votação utilizado foi o Limesurvey, uma plataforma de baixo custo, eficiente e segura, que garante a votação única por meio de *tokens*. A fim de atender ao Estatuto Social da instituição (do Art. 19 até o Art. 23) e ao Regimento Geral (do Art. 53 até o Art. 57), o período eleitoral ficou compreendido entre o dia 27 de setembro e o dia 19 de dezembro de 2022, quando ocorreu, por meio da Plataforma Zoom, a Assembleia Geral que homologou o resultado das eleições. A adesão dos associados com direito a voto foi excelente, pois alcançou noventa e três vírgula sete por cento (93,7%).

### 1. The Sobrac Electoral Process 2023–2024 and 2023–2026

The Electoral Commission, appointed by the Board of Directors under the terms of Article 40 of the Bylaws and Article 51 of Sobrac’s Rules of Procedure, was made up of: Dinara Xavier da Paixão; Gilberto Fuchs de Jesus; Marcos Roberto Barbieri Júnior; Paulo Medeiros Massarani; and Roberto Jordan — see the society’s logo in Figure 1.

## 2. Brief report

The electoral process began with the publication and wide dissemination of the Public Notice, which contained the following timetable:

- September 27: publication of the notice of the 2022 electoral period and calendar;
- **November 3: deadline for applications for candidacy;**
- November 7: publication of the candidacies registered and approved by the Electoral Commission;
- November 11: deadline for submitting registration appeals to the Electoral Commission;
- November 14: publication of the list of voters and approved candidacies;
- **November 15–28: voting period;**
- November 29: counting of votes and publication of results;
- December 10: deadline for appealing the results to the Electoral Commission; and
- **December 19: General Assembly to approve the election results.**

Registrations were made using the electronic forms available at: <https://acustica.org.br/#eleicoes>. In compliance with the institution's legal standards and documentation, candidacies for the Advisory and Supervisory Boards were individual, while candidacies for the Sobrac Board of Directors and its Regional Divisions were collective, indicating the positions and their respective candidates, who electronically formalized consent to their candidacy. The five members who received the most votes during the election period were elected to the Deliberative Council. These five are considered full members and were elected to serve from 2023 to 2026. Candidates for the other positions were elected to serve two-year terms (2023–2024).

The *Limesurvey* voting system, operated by electoral commission member Marcos Roberto Barbieri Júnior, was chosen because it met the following four criteria: it is a low-cost platform; its efficiency is recognized by its use in academic research; the information involved is secure; and there is a guarantee of single vote limitation through the use of *tokens*. Members received their individualized voting link via their email address registered with Sobrac. Reminders were sent by e-mail to members who had not yet voted a few days before the deadline. The total number of ballots sent out to members entitled to vote was 126, with a turnout of 93.7%, giving a total of 118 voters.

As there were no complications, at fourteen hours and five minutes on November 29, the virtual meeting to count the election votes was held via the Zoom platform. The address for monitoring the session was emailed to all members and published on Sobrac's website (<https://acustica.org.br>).

In addition to the members of the Electoral Commission, the virtual meeting was also attended by members of the Executive Board, candidates, and other members. With the authorization of those present the meeting was recorded and monitored by the technical advisor for the digital area, Thiago Antônio Morais Ferreira.

**The elected members:** on December 19, 2022, there being no appeals regarding the electoral process, a virtual General Assembly was held to homologate the results. The new leaders, with their respective positions and terms of office, are:
